Meeting was opened at 7:00 PM. with the Pledge of Allegiance

**Minutes were reviewed** – A motion was made by Commissioner Cooter and seconded by Commissioner Wortley to approve the February 2024 Minutes. The motion was unanimously approved.

**Vouchers were approved-**

A motion was made by Commissioner Malone and seconded by Commissioner Rotery to approve the March 2024 invoices totaling \$249,027.21. The motion was unanimously approved.

**Treasurer's Report-**

1. The bank reconciliations were signed by Commissioner Wortley.

### **Chief's report-**

1. Total calls in February was 18.
2. E-14 had a 110 plug wired for the new tool and fan
3. Matt has scheduled the RP-15 for the plug to be installed.
4. Dans new truck had the lights installed today.
5. Matt is working on getting smoke alarms. Commissioner Cooter will help to find battery operated ones.
6. The Shamrock run is this weekend and we were asked to help with traffic.
7. Joe Nemier is setting up emails for all members.
8. A Firematic Class will be held at the station in the fall.
9. An EVOG Class will be held here next month.
10. Preble will be holding a training for electric vehicles that we will attend.
11. Mitch Goldberg will have holmatrol tool training for our members.
12. Rob is testing out the new gear ordered for him. He did not like the harness was not built in. Dave wants him to beat it up to see how it holds up.
13. Any physical due over 30 days will have their gear pulled.  
Commissioner Malone stated that it should be made available what each member is cleared for. Matt McGarrity collects the physical forms and they are put in a folder. The chief can see the physicals in case there is not an EMT on duty. There was discussion about knowing the weight of gear in case of a weight limitation.

5. Shutes came and looked at the water softener and said it was working fine. Commissioner Wortley still thinks it may not be working correctly. Mapstone said they could put a booster on it.
6. We ordered a new air compressor motor from Grainger.
7. There was discussion about getting a lift to get rid of the old ventilation system. Until it is sold, we should leave it as is. As it is basically being stored.
8. The O rings in the upper reels may need to be replaced. There are shut off valves on each one.
9. The driveway is going to need some attention this year. More to come on that.
10. The chief is going to do a drill to clean the fence. We are going to just keep repairing it at this point.
11. There was a question about the air compressor at Station 2. Is it done or not.
